## **INFORMATION FOR AUTHORS**

IEEE JOURNAL OF THE ELECTRON DEVICES SOCIETY (J-EDS) is an Open-Access, fully electronic journal which is published monthly. It comprises original and significant contributions relating to the theory, design, performance and reliability of electron devices, including optoelectronic devices, nanoscale devices, solid-state devices, integrated electronic devices, energy sources, power devices, displays, sensors, electro-mechanical devices, quantum devices and electron tubes. Tutorial and review papers on these subjects are also published and occasional special issues appear to present a collection of papers which treat particular areas in more depth and breadth. Because J-EDS is an Open Access title, on-line access is accessible to technical professionals worldwide at no charge.

Submission of a manuscript amounts to the assurance that it has received proper clearance from all authors listed, from the authors' companies or institutions where required, that it has not been copyrighted, published, or is either under review or accepted for archival publication elsewhere while under consideration by J-EDS. In cases where there is even a potential for significant overlap between the manuscript and previous work, it is the responsibility of the author(s) to provide references to pertinent previous publication and copies/preprints of manuscripts undergoing pre-publication review elsewhere. Failure to do so will compromise the peer review process and render such papers ineligible for publication.

*Pre-submission Editorial Services:* Assistance with English grammar and usage prior to submitting a manuscript for review or during the review process is available at http://www.prof-editing.com/ieee. The SPi copy editors will edit for grammar, usage, organization and clarity, querying potentially substantive revisions as necessary. An author can use the service at their own expense, as often as desired. Cost estimates are available immediately online. Edited manuscripts will generally be returned to the author within two weeks.

*Plagiarism:* Manuscripts that are found to have plagiarized others including self-plagiarism; copying someone else's work without appropriate credit, that contain a significant crossover with another manuscript by the same authors or other author(s); copying or reusing of one's own prior work without appropriate citation, or that do not specifically cite prior work, are subject to penalty under the IEEE policies governing publications. Submission Procedure: All manuscripts must be submitted electronically using IEEE's web-based Author Submission and Peer Review System, ScholarOne Manuscripts. Please do not send manuscripts directly to the Editor-in-Chief or the Publications Office. Manuscripts must be uploaded to the J-EDS web site at http://mc.manuscriptcentral.com/jeds. A user account is required to submit a manuscript, before creating a new account; please check to ensure that you do not have an existing account which is based on your e-mail address. Instructions for establishing an author's account and for uploading your paper are available on the submission web site.

Submission Format: Manuscripts must be submitted in the two column format using the IEEE Template. The font sizes and line spacing must not be altered when using this template. The template and further guidelines on the preparation of manuscripts can be obtained from the IEEE Tools for Authors website located at http://www.ieee.org/web/publications/authors/transjnl/index.html.

A cover letter stating explicitly that the manuscript is being submitted for publication in the J-EDS must accompany the manuscript. The author should indicate which category in the Table of Contents would be most suitable for the paper. These categories are listed alphabetically: 1) Compound Semiconductor Devices; 2) Materials, Processing, Packaging; 3) Molecular and Organic Devices; 4) Optoelectronics, 5) Sensors and Actuators; 6) Silicon and Column IV Semiconductor Devices; 7) Solid-State Device Phenomena; 8) Solid-State Power and High-Voltage Devices; 9) Thin Film Devices; 10) Vacuum Electron Devices.

*Manuscript Length:* The Electron Devices Society has determined that for J-EDS a manuscript will not be restricted by page length except that verbose

manuscripts will be asked to present the material in a succinct manner to enhance readability. The following guidelines apply to shorter contributions;

*Briefs*: Are short reports of preliminary results on completed work that are of current interest to many workers in the field. The standard length of a Brief is 3 published pages.

*Correspondence:* Includes comments on material previously published in J-EDS, suggestions for new work and errata.

*References:* Submitted papers must provide adequate referencing to prior art. In addition citations must be provided for all technical details that are not fully supported by the analysis or experimental results described in the paper. Failure to do so may result in rejection of the manuscript without further review. Authors should also provide supporting documentation for cited references not yet published. Each reference must have a complete list of authors (no et al.), complete titles, first and last pages numbers, month and year. The length of the references section does not count as part of the total page count and hence does NOT impact the cost of publishing.

*Review Process:* The author will be notified of the Editor-in Chief's decision whether the paper is accepted for publication based on the reviewers' recommendations. In case there are deficiencies, if possible, the handling editor will work with the author(s) to help them improve the quality of the submission to meet the high publishing standards that the readers have come to expect of IEEE Electron Devices Society. The reviewers' comments and all editorial correspondence are confidential information and must not be reproduced, published or distributed elsewhere.

*Free Editorial Services:* Any paper that has been recommended for publication and lacks the rigor of the English language is eligible for free copy-editing service after approval from the editor-in-chief. This is subject to the condition that ALL authors are members of EDS at the time of submission.

*Final Manuscript:* Upon acceptance for publication, the corresponding author will be provided with the final requirements for publication. Detailed instructions for preparing electronic files are available at: http://www.ieee.org/web/publications/ authors/transjnl

*Page Charges:* Upon acceptance for publication, the author(s) will be required to pay a charge of \$1350 for up to eight pages, plus \$120 per printed page thereafter. These fees are to cover the cost of publication and providing free, universal access to all. The outstanding reputation and high quality of J-EDS depends in part on honoring of these charges. Detailed payment instructions will accompany the page proof request.

*Color Figures:* There will be no extra charge for Color figures. Video content can be added as supplemental material at no additional charge.

*Illustrations:* Previously published illustrations (figures, graphs, tables, drawings, etc.) must be so indicated by the line "Reprinted from (name of author, title of paper, journal or source, vol., page no., and date)" below the figure caption. It is the author's responsibility to secure permission from the previous publisher to reprint the material.

*Bios and Photos:* A clear photograph and concise biography of all authors should accompany the submission of the manuscript.

*Clearance and Copyright:* It is the policy of the IEEE to own the copyright to the technical contributions it publishes on behalf of the interests of the IEEE, its authors, and their employers, and to facilitate the appropriate reuse of this material by others. To comply with the United States Copyright Law, authors are required to sign a digital version of the IEEE Copyright Form with their original submission. This form is available online at http://www.ieee.org/web/publications/rights/index.html. However, please note that the since this is an Open Access journal, with proper citation an unaltered version of the published paper can be freely posted and distributed worldwide.

Please note, that if accepted, your manuscript will not be published if a copyright form is not received by the publication office.
